## Frequently Asked Open Enrollment Questions:

- 1) I have recently moved; how can I ensure that I will get my open enrollment information in the mail? If you have moved, you must contact your insurance plan and update your address as soon as possible.
- 2) How can I learn more about specific changes that are taking place in my plan? You will be receiving a booklet by late October from MMB. Read the section entitled "What's New." You may also attend one of the scheduled Open Enrollment Insurance Meetings for Retirees.
- 3) I only want coverage for myself and my spouse; why do I have to pay for family coverage? If you and your spouse are under age 65.

you are in the same Advantage Health Plan as active employees. The current single/family structure for health coverage and all dental coverage is negotiated between the State and the Unions. An employee plus one plan option is looked at on a regular basis by the State and Unions. To date, it has been more cost effective to keep the dependents mixed with children and spouses. At the age of 65, different health plans that include Medicare are available to retirees and these plans have traditionally been issued on an individual basis. Since they are issued in this manner, these can be enrolled in and charged as two individual policies.
