Executive Director and CIO of State Board Of Investment Mansco Perry was named Executive Director and Chief Investment Officer of the Minnesota State Board of Investment (MSBI), effective October 21, 2013. The MSBI is responsible for the management of pension and other state assets, totaling \$80 billion.

Prior to his appointment at the MSBI, Mansco served as the Chief Investment Officer of Macalester College, Chief Investment Officer of the Maryland State

Retirement and Pension System, Assistant Executive Director and Deputy Chief Investment Officer of the Minnesota State Board of Investment. He has held various financial management positions at Cargill, Inc., Dayton Hudson Corporation, Target Stores, the Federal Reserve Bank of Minneapolis and the Minnesota Department of Revenue.

Mansco has a BA from Carleton College, an MBA from the University of Chicago and a JD from the William Mitchell School of Law. He was awarded the Chartered Financial Analyst, the Chartered Alternative Investment Analyst, and the Certificate in Investment Performance Measurement designations. Mansco was admitted to practice law in the State and Federal District courts of Minnesota. He serves on the Board of Trustees of William Mitchell College of Law. Previously, he served on the Board of Directors Minnesota Philanthropy Partners and Catholic Charities of St. Paul and Minneapolis. He has also served as a member of the Investment Advisory Council of the New York State Teachers Retirement System and on the Investment Committees of the Sisters of Saint Joseph of the Carondelet and the University of Baltimore Foundation.

Mansco was born in Newark, New Jersey. He is married to Nancy, and is the proud father of his two young daughters, Katherine Mei Xiaobing and Anna Hua. Mansco is an avid baseball fan and collector of baseball memorabilia. His other hobbies and interests include golf and numismatics.

BOARD OF DIRECTORS 2017 ELECTION PROCESS AND SLATE OF CANDIDATES

Each year, five positions on the Board of Directors for the Minnesota Retired Employees Association are up for election. In the fall of each year, current directors are surveyed to determine their interest in running for another three year term. Subsequently, an announcement is made in the Winter newsletter soliciting MRSEA members who are interested in running to submit a letter of interest and qualifications for board membership. The Nominating Committee of the Board then determines which (if any) of the candidates is recommended for endorsement Any candidate not receiving endorsement may have their name placed on the ballot as well. The election of Board of Directors members takes place at the annual meeting in May. At the meeting, endorsed candidates are requested to make a short statement regarding their work history and reasons for their desire to serve on the Board. Any other candidates requesting to be on the ballot or nominated at the meeting has the opportunity to address the meeting as well. A member nominated from the floor and not at the meeting must provide a written statement to be read at the meeting in which states their qualifications and wishes to be on the board.

Three candidates are current incumbent Directors on the Board. Bicker, Krueger and Maurer. All candidates names will appear on the ballot for the election of Directors at the May Annual Meeting

If a printed ballot is required the ballot election is conducted at the meeting. If no printed ballot is required a voice vote is conducted at the meeting. Each candidate must receive a majority of the vote to be elected. Candidates elected begin serving at the next (June) meeting of the Board.

SLATE OF CANDIDATES

Howard Bicker- Retired in November of 2013 after 43 years with the Minnesota State Board of Investment. For the past 34 years he served as the Executive Director and Chief Investment Officer and was directly responsible for the investment of all the statewide retirement plans.

Jack was a CPA initially employed by the MN Dept. of Agriculture as an accounting officer overseeing

the financial activities of the Grain Division. Subsequent to this position Jack was employed by the Minnesota Office of the Legislative Auditor for 26 years. During this period I was supervisor over the audit of the State Board of Investment for several years, gaining knowledge of the investment of state pension funds and the responsibilities of the individual state pension funds.

Richard Krueger- retired in 2012 after having worked for the State of MN for over 44 years. The last 25 years Richard

worked for the Minnesota Racing Commission including the last 22 years as the Commission's Executive Director. Beginning in 1985 he was instrumental in proposing and implementing the rules governing pari-mutuel gambling and racing. Mr. Krueger served four years on the Board of the Association of Racing Commissioners International and 10 years on that association's Model Rules Committee.

John Manahan- retired in 2003. Having a broad background in the private practice of law, in public service, and in the

political process, John's work history includes: General practice of law from 1973 - 1987, and from 2003 to the present; Deputy State Treasurer from 1987 - 2003; served as the State Treasurer's representative on the Investment Advisory Council of the SBI for 16 years; served as the chair of the Information Policy Council for state government from 1993 -2003.

Fred Maurer- Retired as Pavement Management Operations Coordinator with MN DOT. Serving, as Past President of the

Minnesota Government Engineers Council. Fred has served in a leadership role for the Public Employees Pension Coalition (PEPC) and has served on the MRSEA Board since 2003. Fred is the current Co-Chair of the MRSEA Insurance Committee as well as the serving on Legislative Committee.

CANDIDATES cont.

Board members Beth Arntson and Jeanne Cornish have opted to continue serving on the board by fulfilling a vacant seat which will be appointed by the board. Each seat is a two year term.

Beth Arntson- Retired in 2012 after 36 years with the state in a variety of human resources positions in several agencies. In addition to generalist positions, Beth served as HR Director of Trade and Economic Development for 7 years, Staffing Manager for the MnSCU System for 7 years; Chief HR Officer for Rochester Community and Technical College for 5 years and Workforce Planner for DHS for 4 years.

Jeanne Cornish– Jeanne retired 5 years ago after working at Metropolitan StateUniversity for 23 1/2 years as an academic advisor. Jeanne was in the Minnesota State University Administrative and Service Faculty union (MSUAASF), affiliated with Teamsters Local 320. During that time, Jeanne had started teaching at Metro State, and after 11 years of part-time teaching, decided that she was ready for this new direction. While working at Metro State, Jeanne served for many years on the MSUAASF contract negotiations team was a member of the Joint Labor-Management Committee on SEGIP (also known as the Coalition Bargaining Team during contract negotiations), served as both campus and state union president, and for several years was one of two MSUAASF representatives on MNSCU's DCR Advisory Committee.

LEGISLATIVE COMMITTEE UPDATE

As you know from reading the Minnesota State Retirement System newsletter, MSRS faces a funding deficit due to two factors. One, people are living two years longer according to updated life expectancy tables. In fact, Minnesota has the second longest life expectancy after Hawaii, Two, in 2016 MSRS lowered its assumed rate of return on future investments from 8.5% to 8%. MSRS is proposing lowering the rate further to 7.5% based on expected interest rates, expected inflation, and asset performance projections. Because of the lower expected rate of return more funding is required. These two factors plus lower than expected earnings over the past couple of years has created a funding deficiency of 2.6 billion dollars.

To address this deficiency and put MSRS on a path to full funding they are proposing an

approach which represents a shared sacrifice on the part of retirees, active members and the employer. MSRS is proposing to increase employee contributions by .5% to a total contribution of 6% of salary. The employer contributions would increase, in stages, by 2.5% to 8% of salary. In addition, MSRS is proposing to reduce future post retirement increases (sometimes called COLA) to 1.5%

The Board of Directors of MRSEA is committed to protecting the interests of retirees and the defined benefit pension plan for future state employees. After careful consideration of the situation, the MRSEA Board chose to support the MSRS proposal for two reasons. First, to share the sacrifice of reducing the funding deficiency. Second, to limit the reduction of the COLA to not more than the proposed .5%. We will oppose any reduction larger than .5%. Public Employees Retirement Association (PERA) is currently receiving a 1% COLA and Teachers Retirement Association (TRA) is proposing to reduce their COLA to 1%. TRA had no COLA increase in 2011 and 2012.
